LAST OPPORTUNITY FOR SUBMISSION OF COUNSELLING PARTICIPATION FEES, REGISTRATION FOR ALL CET QUALIFIED CANDIDATES (ALL CATEGORIES) ALSO VERIFICATION OF DOCUMENTS FOR RESERVED CATEGORY CANDIDATES FOR ADMISSIONS THROUGH ONLINE COUNSELLING -ACADEMIC SESSION: 2018-19

Number of CET qualified candidates are still approaching the University regarding for depositing payment of Rs.500/- (towards correction in CET details); submission of Rs.1000/- (towards Counselling Participation Fees) and Verification of Reserved Category certificates, beyond the notified dates; due to one or the other reason on their part and have submitted the requests to allow them for the same.

The University in the general interest of candidates and AS A LAST OPPORTUNITY, the following is informed for all:-

(1) The candidates seeking correction in the CET Details.

The candidates seeking correction in the CET details must also provide a copy of the application in physical form along with the fee of Rs.500/- deposit in Indian Bank GGSIP University, Dwarka, Delhi-110078 and submit the original receipt in the Admission Branch, GGSIP University, Dwarka, Sector 16-C, New Delhi-110078 upto Tuesday, 26.06.218 (upto 02.00 p.m).

(2) The candidates who wish to submit the Counselling Participation Fees.

Candidates can pay the Participation Fee only in the Indian Bank, GGSIP University, Dwarka, Delhi-110078 upto Tuesday, 26.06.218 (upto 02.00 p.m). One receipt of paid Participation Fee of Rs.1,000/- in original must be submitted in Reception Counter, Admission Branch, GGSIP University, Dwarka, Delhi-110078, failing which the registration may not be carried out. Subsequently such candidates, Register themselves and fill choices on 26.06.2018(upto 11.50 p.m)

(3) The candidates who wish to submit challan for correction of CET Details and subsequently submit the Counselling Participation Fee.

Both the procedure mentioned above at point 1 and 2 is to be followed by paying Fees of Rs.500/- and Fees of Rs.1,000/- only in Indian Bank, GGSIP University, Dwarka, Delhi-110078 and the copy must be submitted in Reception Counter, Admission Branch, GGSIP University, Dwarka, Delhi-110078.


(4) The candidates who have submitted the Counselling Participation Fees, subsequently Registered but did not get their category verified at the Designated Centres.

Reserved Category CET qualified candidates can verify his/her reserved category documents on production of valid reserved category documents alongwith a copy of CET admit card in Admission Branch, GGSIP UNIVERSITY, Dwarka, Delhi-110078 upto 26.06.2018 (upto 04.00 p.m).

However, all candidates in their own interest are requested to visit the University website www.ipu.ac.in and www.ipuadmissions.nic.in for regular updates.


