**NOTIFICATION FOR PAYMENT OF PART ACADEMIC FEE OF RS. 40,000/-**  
**THROUGH CHALLAN IN INDIAN BANK IN GSIP UNIVERSITY CAMPUS ONLINE**  
**COUNSELLING (ACADEMIC SESSION 2018-19)**

This is in continuation to University notification no. IPU-7/Online Counselling/2018/4050 dated 13.07.2018 on the subject noted above.

This is to inform to all the registered candidates as well as all the stakeholders that the above notification issued for payment of Part Academic Fee of Rs. 40,000/- through Challan at Indian Bank Branch located at GGSIPU Campus, mentions "...submitted an application along with copy of allotment / offer letter of Round 1 and a copy of challan of Indian Bank of Rs. 40,000/-....." There, an inadvertent typographical error has occurred; as this is to be "...Offer letter of Round 2."

It is thus informed that an inadvertent typographical error has occurred where it has been wrongly typed as "Round 1 and a copy of challan of Indian Bank of Rs. 40,000/-..." It is again requested that this may please be read as "...Round 2 and a copy of challan of Indian Bank of Rs. 40,000/-"

The inconvenience caused is deeply regretted.

The candidates are requested to refer to the point 11.5.2 (iv), Chapter 11 (Online Counselling Procedure), Part-A, Admission Brochure 2018-19 which states that "**Candidates who were allotted a seat in any round but did not pay the part academic fees of INR 40000/- shall not be considered in subsequent round of counselling.**" Further, it is informed that all the CET Qualified candidates are eligible to attend the Spot Counseling irrespective of the status of admission i.e. admitted / not admitted / withdrawn / not reported.

The inconvenience caused due to inadvertent typing error as "Round 1" in place of "Round 2" is, once again, deeply regretted.
